- 1.1.4) If you are unhappy with the way you are represented by the above, you may collect 50 signatures, form a new grouping and apply for POMA membership. You can then have your own representative on the POMA Board.

2) Dredging

We are engaging with the relevant authorities and other parties in a process to break the current deadlock regarding permits. The process is sensitive and we request all interested and affected parties to bear with us, for the moment.

A special "Dredging News" will be published when the time is ripe.

3) Strategy

Our strategy meeting on 13 March 2019 was poorly attended, with only two clients pitching up to make a contribution.

We assume that the decisions taken and implemented last year has taken care of all the concerns, and the following was confirmed for the immediate future:

- 3.1) The BIG DREDGE is still the top priority and the Board is spending most of their attention on the issue of environmental authorisations.
- 3.2) The partnership with the Berg River Municipality which involves a new environmental authorisation to utilise our dredging spoils for repopulation of the river banks and marina embankments has started its work and will probably take 12 18 months to complete.
- 3.3) We are insisting that recognition be given in the Berg Estuarine Management Plan for the maintenance requirements of the Marina. We are working with Anchor Environmental as consultants in this regard. The DEA is currently preparing a final BEMP before taking it to a public participation process.

- 3.4) The new Board will continue with making the professional POMA Management Team more independent from day-to-day Board engagement. This will allow the Board to play the oversight role it is intended to do and lighten the load on board members. An EXCO will be the go-between and the dredging will still be the responsibility of the Dredging Committee.
- 3.5) The development of the Yacht Basin is taking a back seat to the dredging priority at the moment. However, following the process last year, the Board has received written mandates to guide it in decision making once we are in a position to start with the planning.
