1) Governance

Your Board and the Executive Committee are meeting regularly as per the predetermined meeting schedules. The meetings are attended well by all representatives.

We have received the Audited Financial Statements for the 2020 financial year from our auditors and these have to be approved by your Board at its next meeting on 23 June 2021. We can report that the audit was completed unqualified, which is always a sign of good governance and therefore appreciated.

Once approved, it will be circulated to the Membership together with the Chairman's Report for 2020.

2) Dredging

2.1) The Dredging Committee, chaired by Derek Robinson, is hard at work, completing the applications for the Dumping and Discharge permits with the help of our consultants, Messrs WSP. Some of this work is highly technical, and regular (virtual) meetings are taking place to ensure that WSP is well informed. (Please note that a "completed" application means that all the questions from the Department have been answered.) WSP, aided by our resident ECO, Dr Sue Tonin, has attended two meetings with the Department to ensure that we have perfect understanding of what is required.

We shall keep you informed as we proceed.

2.2) Unfortunately there has been no progress regarding the finalisation of the Berg Estuary Management Plan (BEMP). You will recall that we have fought hard for the inclusion of the POMA dredging requirements in the BEMP, and it is crucial for our permit application completion.

So, we have been asking for these appointments and now that they are here, we must expect them to do their work. Please ensure that the paperwork on the boat is correct and up to date, and give them your support. They have an important role to play in ensuring the quality and future of the estuary.
